Thank you for your interest in being a Vendor / Exhibitor at this year's Sebastian Clambake! Space is limited, and sites are assigned on a first-come, first-served basis, so we recommend reserving your site as soon as possible. Returning Vendors have will receive last year's site if postmarked is prior to August 1, 2021. This festival is a charity fundraiser.

No vendors offering food or beverage for on-site consumption will be allowed; the Sebastian Clambake Foundation will provide these items. Political vendors are not permitted at this event. Vendors / Exhibitors are responsible for supplying tents, tables, 5lb ABC Fire Extinguisher and other equipment necessary for their display. Tent must be approved fire resistant. See attached Indian River County application for your display. It must be filled out and returned with your application.

Setup will be Thursday 12:00 Noon - 7pm and Friday 8am-noon. Set-up must be completed by 12:00 noon on Friday. Please note that Sebastian BLVD will be closed as of Friday morning and you will not be allowed in on any closed roads. Limited security will be available Thursday night.

"Tent Sites" are a maximum of 10' x 10'. You must keep your display within the space provided

To reserve your site, fill in out the Vendor / Exhibitor application and agree to the event rules. Send your completed application and event rules (signed) with the registration fee to:

**RULES FOR EVENT**

1. Exhibitors must not deviate from the product / information described in their application.
2. No political displays or politicking anywhere on event grounds.
3. No oversized, unmanageable exhibits. Stay within your assigned site, including the back side.
4. Vendor / Exhibitor displays must be staffed always by at least one adult and must be open during event hours. No children under 18 should be left unattended.
5. All displays, tents, tables, exhibits, etc. must be a minimum of 3' off the sidewalks. The line will be marked for you. You will be required to make any adjustments to your display space if requested to do so at any time during the event by any staff member.
6. All exhibits must be set up and ready for business by Friday noon. NO EXCEPTIONS. All closed roads are off limits Friday morning until the Sebastian Police department okays opening Sunday evening. NO EXCEPTIONS.
7. **ABSOLUTELY NO VEHICLES ALLOWED IN THE PARK.** We have carts to help transport your materials.  
All vendor parking will be in the South overflow parking lot.
8. No pets are allowed in the park during events.
9. No smoking is allowed in the park.
10. No soliciting is allowed outside of your booth area. If you are warned then continue, you will be asked to leave the Festival. This includes any product or displays outside of your area.
11. Exhibitors are responsible for cleaning up their area before leaving on Sunday evening. If the site is left uncleaned, you will NOT be invited back.
12. No water, food, or beverage may be sold or given away free from your booth.
13. No adult-oriented merchandise with sexual connotations or merchandise that could be considered drug paraphernalia or smoking materials of any kind, will be allowed.
14. No guns will be allowed in the park for any reason.
15. Vendors/Exhibitors are not entitled to complimentary food or drink from the Clambake booths.
16. Valuables should not be left unattended. The Sebastian Clambake Foundation does not assume responsibility or liability for theft, damage, or other loss of vendors' property and/or possessions.
